Bluff City Board of Mayor and Aldermen Special Called Meeting October 17, 2017 11:00 A M

Mayor Wells called the meeting to order at 11:00 a.m.

Mayor Wells stated that this is a business meeting not a court of law and we welcome each of you here tonight.
