First Session of Public Comments: None

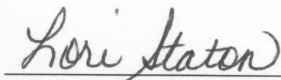

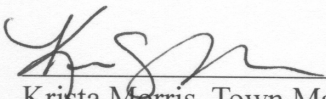

FOR THE PURCHASE OF TWO PUBLIC WORKS TRUCKS
IN THE AMOUNT OF \$104,984.00. STATED VEHICLES WOUL
REPLACE PREVIOUSLY INOPERABLE VEHICLES.**

WHEREAS, the authorization for these vehicles is \$104,984.00; and

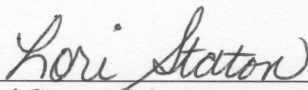
WHEREAS, the Board of Mayor and Alderman wish to pay cash for these vehicles.

1. That Ordinance No. 2025-009 as to the line item 110 – General Fund be amended as follows:

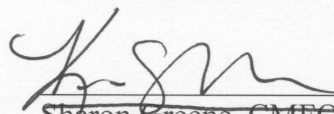

2. This ordinance shall take effect from and after its final passage, the public welfare requiring it.



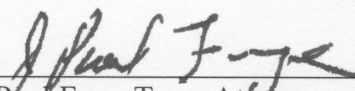
